- IB Fees include: Trip to represent school at an Inter School Level. Fees Do Not Include the Following: Educational Trips & CAS Trip, Books, Graphic Calculator (Issued only Once) and & Examination Fees.
- ECA Fees are charged in October December bill for 2 quarters (July- September & October December) together. To be charged also in January- March Quarter bill. No ECA billing in April- June quarter bill.
